11. Oral Reports from:

A. Student Trustees' Report

Student Trustees shared:

- They are reviewing the data and results from last year's student voice survey, which was opened in May for Grade 7 to 12 students across HWDSB. They received approximately 4500 responses.
- The first student Senate meeting of the year, which will take place on Wednesday, October 26th.
- They worked with the communications department to film the autocomplete interview that was inspired by the popular wired series and answered questions about the role of a student trustee and how students can get involved at the Board.
- OSTA Executive Council met with Minister Lecce at the September 17, 2022 meeting where they were able to discuss curriculum modernization and providing student feedback.
- The attended a Roundtable hosted by the Ministry of Citizenship and Multiculturalism to develop a provincial anti hate plan. The Roundtable was held on October 13, 2022 with representatives.
- HWDSB Eco Summit October 18, 2022 secondary students and guest speakers have been invited to gather at the board office to share environmental concerns ideas and action items that student leaders can take back to their local communities.
- The Fall General Meeting is being held from October, 20-23, 2022.

B. Director's Report

The Director shared the following:

- HWDSB has released its communication standards publicly.
- The Director has been visiting a number of schools, including Westmount Secondary Hess Street Elementary and Bernie Custis Secondary, Prince of Wales and Nora Frances Henderson and most recently the archives at Hill Park.
- She has enjoyed seeing the school renewal in action in our spaces and has had the opportunity to see some of the partnerships in action.
- HWDSB has a policy on Anti-Black Racism and Human Rghts and she is extremely proud to be staffed in the Board that has prioritized these.
- HWDSB strives to keep its community informed about the status of Labor relations with employee groups in our school board. HWDSB is committed to timely communication with staff and families. We have prepared a labor update section on the HWDSB website to begin communications and updates with families.

C. Chair's Report

The Chair shared the following:

- It has been a very busy month for Trustees who are now able to visit their schools once again.
- The Chair acknowledged that our education workers represented by CUPE have filed a no board report as of October 7, 2022 and that is in response to central bargaining. It puts the caretakers and maintenance workers in a legal strike position as of November 3, 2022.
- Central bargaining continues to happen and the Board wants to see all of our groups reach a fair deal with fair compensation because that is where that is negotiated.
- The Ministry of Education has said that they do not want to see disruptions for our students and our schools and our Board feels the same way.

Dear Minister Lecce:

At the September 21st, 2022 meeting of the Halton District School Board (HDSB), Board of Trustees meeting, the Board passed the following resolution requesting the Minister of Education revoke and replace wording in Section 264(1)(c) of the Education Act:

Be it resolved that the Chair in collaboration with the Director write a letter to the Minister of Education regarding Section 264(1)(c) of the Education Act, requesting that this section be revoked and replaced with a clause that is inclusive of Ontario's diverse population.

Section 264(1)(c) of the Act under Duties of teacher states:

(c) to inculcate by precept and example respect for religion and the principles of Judaeo-Christian morality and the highest regard for truth, justice, loyalty, love of country, humanity, benevolence, sobriety, industry, frugality, purity, temperance and all other virtues;

We believe this is contrary to Provincial PPM 119 (Developing and implementing equity and inclusive education policies in Ontario schools) which states: "*Providing a high-quality education for all is a key means of fostering social cohesion* **based on an inclusive society where diversity is affirmed within a framework of common values that promote the well-being of all citizens**." It is these common values that should be the focus.

The three goals of the Province's *Realizing the Promise of Diversity: Ontario's Equity and Inclusive Education Strategy* are outlined in PPM 119, as follows:

- shared and committed leadership by the ministry, board, and schools to eliminate discrimination through the identification and removal of biases and barriers.
- equity and inclusive education policies and practices to support positive learning environments that are respectful and welcoming to all.

In this spirit, we respectfully ask the Minister to revoke and replace Section 264(1)(c) of the Act to reflect contemporary and current diversity, equity and inclusion policy and practices, and to reflect the Calls to Action 62 and 63s brought forward by the Truth and Reconciliation Commission.

COMMITTEE REPORT

The committee held a meeting from 5:32 p.m. to 6:45 p.m. on May 16, 2022 at 20 Education Court, Hamilton, ON, virtually through MS Teams, with Trustee Dawn Danko presiding.

Members present were: Trustees Becky Buck, Dawn Danko and Maria Felix Miller. Regrets from Trustees: Paul Tut and Alex Johnstone.

ACTION ITEMS:

A. Trustee Honorarium

Staff presented the Trustee Honorarium report to the committee. Ontario Regulation 357/06 "Honoraria for Board Members" of the Education Act sets out the method for calculating the limits on honoraria paid under section 191 of the Act. HWDSB Trustee Honorarium policy is based on this regulation and set forth the components of the honorarium which include a base amount, an enrolment amount, an attendance amount and a distance amount – the distance amount is not applicable to HWDSB.

The honoraria for the 2022-23 term commencing November 15, 2022 has been calculated as follows (excluding an attendance amount*):

- Chair \$21,227
- Vice Chair \$17,492
- Other Trustees \$13,757

*the attendance amount will be applied in the amount of \$50/meeting, following the trustee attending one of the four legislative committee meetings.

Moved by Trustee Miller, the Governance Committee **recommends that the Trustee Honorarium, starting November 15, 2022 be the approved.**

B. Electronic Meeting Participation

Chair Danko provided an update to the committee in regards to Ontario Regulation 463/97, under Regulation 630/20, which allowed school boards to run fully electronic meetings until Nov 14, 2022. Following consultation with boards, OPSBA issued a letter requesting extension of the legislation for the 22/23 school year (Sept 29, 2022) and also requested a working group be formed to update the Education Act re: electronic participation. There has not been a response received from the Ministry of Education to date and it is expected that school boards will revert back to existing legislation for meeting requirements as of Nov 15, 2022. Electronic participation will still be permitted as an accommodation, however, the following physical requirements will be in place:

For Board Meetings, the physical attendance requirements are:

- Chair of the Board or designate
- At least one additional member of the board
- Director or designate

* The Board may refuse to provide a member with electronic means of participation if necessary to comply with physical attendance requirements.

For Committee Meetings, the physical attendance requirements are:

- Chair of Committee or designate
 - If the chair/designate participates electronically**, at least one additional member of the Board
- Director or designate

* The Board may refuse to provide a member with electronic means of participation if necessary to comply with physical attendance requirements.

** The Chair may participate electronically if illness or unsafe travel conditions prevent them from attending in person.

Under the Education Act 218.1, a member of a board shall attend and participate in meetings of the board, including meetings of board committees of which he or she is a member. Members of the Board shall be physically present in the meeting room of the board for at least one regular meeting of the board for each 4 month period starting Nov 14th, 2022. HWDSB encourages physical presence for board meetings whenever possible.

Moved by Trustee Miller, the following recommendations are being made for the incoming Board of Trustees regarding electronic participation and hybrid meeting:

Recommendation I: Voting

- Require active voting in favour
- Members in person and electronic vote using their physical hand/arm up;
- Chair state those voting in favour/against to have it clearly recorded
- In order be counted as present in the meeting to vote, trustee must be visible on camera for a vote

Recommendation 2: Electronic Visibility

- During roll call, require trustees be visible on camera to be counted as present in the meeting and part of quorum
 - Trustees are reminded that if they participate electronically, they must immediately inform the Chair and Minute Recorder when they have stepped away from the meeting/returned to the meeting
- Require trustees be visible on camera to speak in a meeting of the board/committee
- Strongly encourage trustees to be visible on camera at all times during a meeting so that they are visible and accountable to committee members and the public

Recommendation 3: Closed Session Participation

- Require trustees be visible on camera to participate in private session.
- During roll-call, electronic participants must declare verbally that they are in a private space and that the meeting cannot be heard by others

CARRIED

The Governance Committee also requested that the Chair write a letter to the Minister of Education highlighting support for OPSBA's letter that the legislation be extended for electronic meetings and highlight the experience seen in Hamilton with the increased public observation of meetings due to the increased access to trustee meetings, as well as the increased ability for all Trustees to participate in additional committee meetings without the need to drive to a physical location.

The committee held a meeting through MS TEAMS from 5:39 p.m. to 6:49 p.m. on October 25, 2022 with Trustee Becky Buck presiding.

Members virtually present were: Trustees Kathy Archer, Becky Buck (Chair), Penny Deathe and Maria Felix Miller.

MONITORING ITEM:

A. Student Learning and Achievement Report

Staff provided an update on the Student Learning and Achievement Report. Staff shared that this report is both looking back on the achievements of the 2021-2022 school year as well as forecasting the goals for this upcoming year. There are two particular goals that staff are focusing on:

- One is improving the graduation outcome of all students and closing the gap for those students currently and historically underserved. The target for that goal is to have 80% of students from grades seven through 12 on track towards graduation.
- The second goal is improving the reading achievement for all students and closing the gap for students who are currently and historically underserved. They are looking for 75% of the students from grades one through 6 in meeting the provincial standard, meaning a B, or at least a B minus in the reading strand of their June report card.

Staff spoke of three broad strategy areas.

- I. Investing in people which is professional development and professional learning and providing resources to staff.
- 2. Leveraging effective practices. Identifying what works in terms of improving student learning and achievement and then working to implement those in all of the classrooms.
- 3. Refining the measures of progress.

Staff spoke about Universal Design for Learning (UDL). It is one of the most evidence-based practices that supports the learning of all students, regardless of who they are, regardless of their needs and in the case of specialized services, regardless of their disability or the complexity of their needs because of their disability. UDL focusses on designing lessons, assessment, evaluations and learning spaces with the most diverse learners with the most complex needs in mind and working to create learning spaces to better meet the academic and social inclusion needs of these students.

Annual Plan Goal #I – Graduation

Staff outlined the strategies to meet the graduation goal including:

- Professional Learning and Resources on inclusive classroom practices.
- Additional Student Success teachers and grade nine lead teachers.
- De-streamed pathways opportunities.
- Tutoring Supports.

Annual Plan Goal #2 – Reading

Staff outlined the strategies to meet the reading goal including:

- Reading Specialist in all High Priority Schools.
- Professional Learning on Phonological Awareness and Phonics, with additional resources (decodable texts and Milestones).
- Tutoring Supports.

On recommendation of the Program Committee, the Student Learning and Achievement report was received.
